- Proposal to modify quorum requirements and to revise the structure for meeting health check-ins:
 - Remove quorum requirements for voting. Votes would be taken with all those

 PDX meetings, not including those who have missed two or more quarterly
 meetings in a row.
 - Rather than requesting reports from all meeting secretaries during quarterly
 meetings, secretaries would be asked to send a report via email (or submission
 form). We would instead leave space for meeting secretaries to reach out about
 needs or concerns. This proposal is for our secretary and co-secretary to revise
 our structure for meeting check-ins.
 - Vote called and seconded Motion passed

 - Global has a very large surplus of finances. We would like to put more into our local community rather than putting that money towards the global community.
